The first dog park was at Fairgrounds Park (now called Liberty Park), and it was very popular, so they added a second at Heritage Park, on the other side of the city. Definitely worth doing. Not only for people to be able to exercise pets, but other social events like "Doggie Palooza."	No feasibility study	General fund; located in established city parks, so park staff maintains them. They do turf management using organic materials (same as is done in other areas of all the city parks); not doing rotation of offleash areas.	Liberty Park (formerly Fairgrounds Park) underwent extensive, multimillion dollar renovation recently. JJR in Madison, WI, did the renovation, so JJR most likely handled the dog park renovation (not 100% sure). But the King's Run Dog Park in LP was definitely professionally designed and upgraded as part of the LP renovation. Small and large dog areas, separated by pavilion.	Posted at both parks and online.
