Mt. Juliet	This works for our size city because we have around 160 employees. The system we have is basic because, people can electronically complete the application and upload a resume and cover letter. When the candidate clicks enter, the system sends it thru email to HRI where, the information is printed and put into an Open Position folder. When the job opening closes, no more applications can be accepted because it isn't listed on the site anymore. HR can log into Civic Plus and pulls an excel spreadsheet with all of the applicants, addresses, email, & phone number. This can be used for auditing. The only drawback is that it isn't linked into the HRIS System in Paycor. Therefore, when the person is hired, all of the information has to be typed into the paycor HRIS System. The upside is that it is a lot less expensive.
