
Section 3 – Response Data by Population Category and Grand Division






Do you have resources in place to be able to do contact tracing (through your health department or other agency) in order to determine people who may have been exposed to an infected individual?


If an employee of your city or county is determined to be infected, do you have procedures in place to quarantine that individual until he or she is no longer contagious?




Are your employees adequately trained in good hygiene and social distancing practices?




Do you have trained personnel who are tasked with screening employees and members of the public as they enter your facilities?

Section 4 – Written Analysis

This Municipal Government Readiness survey (#5) was collected within the same final 24 hours of the TML COVID-19 Local Orders, City Closures and Services survey (#4). It was issued as a joint survey with the counties at the direction of Governor Lee's Economic Recovery Group.

One hundred sixty (160) cities responded to this survey. The breakdowns of response for most questions is found in Section 3. TML's written analysis for this survey is limited to the open-ended comment responses provided in question 10.

Question 10: If, in your opinion, your city or county has unmet needs that must be resolved before reopening to public access, please list those needs here. These requests will be compiled and sent to the Governor's office.

Many of the unmet needs cited in the comments submitted match the trends revealed in previous TML surveys. All cities remain open for business with their residents and are able to maintain services. Several cities commented they intend to keep municipal facilities closed to the public as they have proven their ability to provide services while "closed." These cities intend to take a wait-and-see approach, taking note of public health data in the near term as reopening phases in.

Reopening Facilities

Many spaces are not designed with social distancing in mind, and cities identify many facilities that can't reopen while avoiding person-to-person contact. Obviously, with recreational centers, pools, and playgrounds being in close contact with others is common. Cities mention remodeling needed to prepare for reopening. Physical additions to facilities are required, such as plexiglass barriers at counters where employees interact with the public.

PPE

Cities still don't have enough PPE and this is a primary concern for most. There is not enough PPE for first responders who need N95 masks and gloves. There are not enough disposable masks for other city employees or potential visitors coming to reopened facilities. Cities have ordered masks, gloves, and other protective equipment that still hasn't arrived weeks later. Cities are struggling to find these products, and they're troubled by the prospect of competing with other governmental and health care entities meeting their own demand. Cities want assistance getting this equipment.

Cleaning Supplies

Like PPE, cities are struggling to find enough cleaning supplies. This includes disinfectant sprays, disinfectant wipes, hand sanitizer, and soap. As with PPE, cities are unable to find the quantities they need, have made orders that are still not delivered, and fear competing with other entities to meet their demand. Products are needed for employees to be safe and also for potential visitors at reopening municipal facilities.

Cities also report that employees fear being responsible for cleaning higher risk spaces like public restrooms.

Testing

There is still not enough testing available across Tennessee. Cities need more supplies, including reagent. Where testing is available results are not timely. Cities want to have enough testing capacity for asymptomatic people in their community. Cities also want the ability to do contact tracing or to have stronger partnerships they can support to improve capacity for it in their community. Cities also want reliable antibody testing.

Communication of Public Health Information

Cities want timely, accurate information about infections in their jurisdiction. Cities understand the limitations of HIPAA, and they are not interested in name and address information of those infected beyond the limited use for first responders. Cities want a count of daily positives and tests within their community so they can make the best decisions for their residents.

Expectations and Enforcement

Cities want clear guidance on what is mandated vs. suggested. Cities need clear guidance and clear expectations. Cities need the ability to address concerns from local businesses and residents. Cities are ready to enforce the law as empowered by the governor. Cities fear that a lack of enforcement will lead to a significant increase in noncompliance of repeat offenders.

Screening/Monitoring

Cities have ordered thermometers for taking the temperature of employees and potentially screening visitors to municipal facilities. Cities currently don't have enough equipment for screening and monitoring as acquisition of these devices suffers from the same challenges as PPE and cleaning supplies. Cities want a model policy with lawful procedures.

Public Meetings

Cities want to be able to continue to meet remotely and safely as social distancing is still in place. Cities want an extension of Open Meetings accommodations made to facilitate these safe practices.
