Blaine FY 2019-2020 Agency User Agreement

This agreement is made and entered into between the Grainger County Emergency Communications District (GCECD) and the City of Blaine for the purpose of dispatching calls for service for the police department within the City of Blaine.

GCECD agrees to dispatch all police units either by radio or telephone communication to any and all calls for service. GCECD will create a CAD event for all such calls initiated by the public or the City's Police Officers. GCECD will also maintain a computerized record and voice recording of all police activity.

GCECD will function for all practical purposes as an agent of the City and make available to the City of Blaine all resources of the GCECD such as maps, addresses, recordings, NCIC information, and countywide Pictometry.

GCECD agrees to have two (2) dispatchers on duty 24 hours a day seven (7) days a week at the dispatch center to answer emergency and non-emergency calls for service.

GCECD agrees to furnish the City of Blaine with ON LINE PICTOMETRY. The Pictometry project will include street, address, and parcel data for all of Grainger County. The GCECD agrees to have the corporate City limits flown at a lower altitude for clearer and better images.

The City of Blaine agrees to maintain Motorola Moto Trbo Digital Radios with GPS tracking to comply with the Dispatch Center's digital radio/tracking system. Due to the sensitivity of the system, Blaine agrees that any radio unit that is not tracking will be taken out of service until repaired. If the unit remains in service, the Director will notify the Chief in writing of noncompliance. Forty-eight business hours after notification the GCECD Director will send a signal to the radio to cease operating which takes it out of service until it can be repaired by Metro Communications. The City will also abide by any and all communication rules and procedures set forth by the GCECD, TBI/FBI, and the FCC.

The City of Blaine agrees to pay GCECD the sum of Thirteen Thousand Two Hundred Dollars (\$13,200) for one (1) fiscal year of dispatch service and Pictometry project information beginning July 1, 2019, and ending June 30, 2020.

The City of Blaine agrees to make payments to the GCECD
 Monthly
 Quarterly
 Annually

If at any time the City of Blaine fails to make its contribution to GCECD, GCECD has the right to void this agreement within thirty (30) days after giving the City of Blaine written notice.

If at such time the agreement becomes void for non-payment, GCECD will cease to dispatch calls for service to the City of Blaine .

Emergency 911 calls are in no way a part of this agreement. 911 calls will by some means always be provided to the appropriate agency.
